IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Broker Statement

MR. HARRIS DENIES THE ALLEGATIONS OF THE CLAIM, WHICH WAS SETTLED WITHOUT ADMISSION OF LIABILITY IN ORDER TO AVOID THE COSTS AND UNCERTAINTIES OF FURTHER LITIGATION. MR. HARRIS STATES THAT THE CLIENT'S ACCOUNTS WERE INVESTED IN A BALANCED FASHION, WITH THE MAJORITY OF THE ASSETS IN A CONVERTIBLE BOND AND CONVERTIBLE PREFERRED PORTFOLIO, AND THAT THE TRADING DECISIONS IN THE ACCOUNTS AT ISSUE WERE MADE BY THIRD-PARTY MONEY MANAGERS, NOT MR. HARRIS. MR. HARRIS FURTHER STATES THAT THE CLIENT'S LOSSES WERE PRIMARILY THE RESULT OF MARKET FORCES DURING THE TIME AT ISSUE (APPROXIMATELY EARLY 2000 TO MID-2002), WHICH WAS A PERIOD OF SUBSTANTIAL MARKET DECLINES.
