What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

1. Mr. McGuire has been licensed to sell insurance to clients since 2013. He currently provides insurance services through McGuire Retirement Solutions, LLC in Bethany, Oklahoma. He is the owner and managing member of that company. He spends approximately 10 hours per month on his insurance business, 10 hrs during trading hours. The business of Retirement Solutions is investment related.
2. In May 2021, Mr. McGuire formed McGuire Holding Company, LLC, an Oklahoma limited liability company, to hold title to the office building where McGuire Capital maintains its offices and it shares office space in that building with McGuire Capital. Mr. McGuire is the Managing Member. He devotes less than five hours a month to the business of the holding company, none of which is during trading hours. The business of the holding company is not investment related.
3. In 2007, Mr. McGuire and another individual formed Sooner Cash Advance, LLC, an Oklahoma limited liability company, that holds real estate investments. The business is based in Oklahoma City. He devotes less than five hours a month to the business of the holding company, none of which is during trading hours. The business of the company is not investment related.
4. In April 2024, Michael W. McGuire formed McGuire Tax Advisors, LLC, a tax advisory and tax preparation business. He is a co-owner and spends approximately 2 hours per month on this activity.

 - A "resolved" matter usually includes a disposition wherein no payment is made to the customer or there is no finding of wrongdoing on the part of the Investment Adviser Representative. Such matters generally involve customer disputes.
