IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Broker Statement

I dispute the allegations in the Form U5 filed by HFP Wealth Management LLC ("HFPWM"). Those allegations are false and misleading. Contrary to HFPWM's assertions in its U5, I did not violate applicable investment-related statutes, regulations, rules or standards of conduct.

I was an independent contractor to HFPWM. I had direct contact with clients, frequently requesting and receiving confidential information necessary to work on their cases. In the normal course of my work, I used various software applications to help with client work.

The U-5 alleges a violation of HFPWM's Code of Ethics by use of a third-party portal. This is not true. I used applications that help with the normal course of client work - no applicable restrictions were violated. Clients were informed the applications were being used. No client was misled. The U-5 also states that "On September 13, 2018, Mr. Streiber was provided HFPWM documentation regarding his actions." Again, this is not true. I was not given any documentation regarding these allegations at the meeting on September 13, 2018. The relationship with HFPWM was scheduled to terminate on December 31, 2018. By terminating the relationship three and a half months early and repeating the false and misleading allegations above, HFPWM retained some large clients who had previously indicated they would move with me after separation from HFPWM.
