IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Allegations: CLIENTS ALLEGED THAT I REPLACED THEIR PREVIOUS ANNUITY CONTRACT IN 1994 FOR THE BENEFIT OF COMMISSIONS FOR MYSELF. FURTHER, THEY ALLEGED THAT THE 10 YEAR SURRENDER CHARGE SCHEDULE ASSOCIATED TO THEIR TWO NEW ANNUITY CONTRACTS IS INAPPROPRIATE. FINALLY, THEY ALLEGED THAT I WAS UNRESPONSITIVE TO REQUESTS FOR INFORMATION ON THEIR ANNUITY CONTRACTS. THEY REQUESTED THAT THE SURRENDER CHARGES ON BOTH OF THEIR ANNUITY CONTRACTS (TOTALING \$7,351.58) BE WAIVED.

Broker Statement

THE FIRM FOUND I PROVIDED THE CLIENTS FULL AND FAIR-DISCLOSURE OF THE NEW ANNUITY CONTRACTS THEY PURCHASED. FURTHER, THEY FOUND THE NEW ANNUITY CONTRACTS WERE APPROPRIATE AND SUITABLE GIVEN THE CLIENTS AVERSION TO RISK, AS THEY HAD HIGHER FIXED RATE OF INTEREST THAN THEIR PRIOR CONTRACTS. AS THESE ANNUITY CONTRACTS WERE EARMARKED FOR THE CLIENTS RETIREMENT, SOME 19 YEARS FROM THE TIME OF PURCHASE, THE NEW SURRENDER CHARGE SCHEDULE WOULD NOT BE AN ISSUE. I RESPONDED IN A TIMELY MANNER TO THE CLIENTS' REQUEST FOR INFORMATION ON THESE ACCOUNTS. THE FIRM DECLINED TO WAIVE THE SURRENDER CHARGES. IT APPEARED A COMPETITOR WAS INVOLVED.
