HE GAVE ME THE WRONG NUMBER OF CONTRACTS TO BUY/SELL BECAUSE OF A STOCK SPLIT, AND THEREFORE THE TRANSACTIONS RESULTED IN A \$10,000.00 LOSS. HE STATED IN HIS LETTER TO US THAT "I DID EXACTILY WHAT HE ASKED" BUT THE NUMBERS DON'T MAKE SENSE.
