What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Broker Statement

This complaint is without merit. I recommended a suitable investment to an investor who sought out and was eligible to invest in private equity. I provided full and accurate information about this investment in 2015, and the client performed his own review and diligence prior to investing. Before he decided to invest, my client received a Private Placement Memorandum, the Limited Partnership Agreement, and the Disclosure Agreement and Subscription Booklet. He also executed a Disclosure Letter that set forth the risks associated with this investment. Unrealized losses on this investment at the time of the complaint are the result of private market valuations, sector forces and other economic factors, among other things, occurring approximately 5 years after his initial decision to invest and are outside of my control. The departure of the fund manager appeared to upset the client, triggering this complaint, and he sought to exit the investment as a result.
