### What is included in a IAPD report?

### Where did this information come from?

THE CLIENT CLAIMED THAT HER ANNUITY CONTRACT SAYS THAT SHE WAS 74 WHEN SHE PURCHASED THE INVESTMENT; HOWEVER, THAT SHE WAS ACTUALLY 84 AT THE TIME OF PURCHASE. THE CLIENT STATED THAT SHE DID NOT BELIEVE THE INVESTMENT WAS SOLD PROPERLY BASED ON HER GOALS AND OBJECTIVES. THE CLIENT SEEKS TO SURRENDER THE ANNUITY CONTRACT IN-FULL WITHOUT BEING CHARGED ANY SURRENDER CHARGES. SURRENDER CHARGES ARE BELIEVED TO BE APPROXIMATELY \$7,105.75.
