IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Broker Statement

I believe the allegations here to be baseless. I reached out to this client many times on a yearly basis to do a review. Many of my calls were never returned. Before any investment management program was set up, I reviewed the paperwork and the signature page with the client. This paperwork included a list of all fees being charged annually. The client was also made aware that all fee charges were reflected on the monthly statement on a running YTD basis. During reviews we went over the RISK profile, performance over several time frames and UBS' outlook on the market. It was always noted to the client that all return figures on the performance reviews were shown net of all fees. I have had and requested many review meetings with the client to discuss the allocation of the current portfolio and diversifying the equity concentration risk. Diversification became particularly important due to the client's personal situation. We discussed concentration risk and how it could affect the future. Any decisions made regarding the purchase or sale of equity or fixed income securities in the non-discretionary portfolio were collaborative and were approved by the client. There was also a thorough discussion of the tax consequences before any trades were made. Yearly, during the 4th quarter, we would revisit the realized tax summary for the year and strategize. My advice for this client was based on the information I had at the time and what I considered to be in the best interest of the client.
