What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

TO MANGAGE HER PORTFOLIO ON A DISCRETIONARY BASIS. DURING THE 2000-2003 BEAR MARKET, THE ACCOUNT PERFORMED POORLY. DURING THIS TIME PERIOD ROXBURY CAPITAL MANAGEMENT MADE ALL THE INVESTMENT DECISIONS. [CUSTOMER'S] ALLEGATION THAT I MADE UNSUITABLE TRADES IN INCORRECT SINCE SHE AUTHORIZED ROXBURY CAPITAL TO HAVE COMPLETE TRADING DISCRETION ON HER ACCOUNT. DURING THIS PERIOD, I SPOKE WITH [CUSTOMER] NUMEROUS TIME ABOUT HER INVESTMENTS AND THE MARKET. AT THE END OF EACH PHONE CALL SHE DECIDED NOT TO HAVE A PERSONAL MEETING TO DISCUSS HER ACCOUNT AND SHE DETERMINED THAT NO CHANGE SHOULD OCCUR DUE TO HER LONG-TERM INVESTMENT TIME HORIZON. UNFORTUNATELY, HER PORTFOLIO DECREASED IN VALUE DUE TO THE THREE YEAR BEAR MARKET AND HER INABILITY TO DISCUSS AND INVEST IN ALTERNATIVE STATEGIES.
