What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Allegations: SOLD THE MEMBERS AN AGGRESSIVE VARIABLE ANNUITY FUNDED WITH \$140,000 FROM SURRENDERS OF TWO PAID-UP WHOLE LIFE POLICIES AND A 1994 VARIABLE LIFE POLICY. THE MEMBER ALSO CLAIMS THAT SHE WAS NOT INFORMED OF THE "STIFF" SURRENDER CHARGES OR OF A RATING ON THE NEW 2ND TO DIE LIFE PRODUCT DUE TO A HEALTH CONDITION AND WAS PROMISED THAT THE VARIABLE ANNUITY GROWTH WOULD MORE THAN PAY THE \$9000 ANNUAL PREMIUM OF THE NEW LIFE CONTRACT. CONTRACT IN DISPUTE IS PART OF CLASS ACTION LITIGATION, CURRENTLY IN THE SETTLEMENT PHASE. AS MEMBER DID NOT OPT OUT OF THE CLASS, NO SETTLEMENT IS CONSIDERED.
