What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

THE INVESTMENTS WERE PURCHASED ON 1/31/08, AND THE CUSTOMER RECEIVED CONFIRMATIONS AND ACCOUNT STATEMENTS REFLECTING THE ACTIVITY IN THE ACCOUNT. THE FA IS CERTAIN HE DISCUSSED THE INVESTMENTS PRIOR TO THEIR EXECUTION, AND THE INVESTMENTS IN QUESTION WERE THE ONLY TWO PURCHASES OF SECURITIES IN THE 401(K) ACCOUNT IN 2008. THE FA IS ALSO CERTAIN THE CUSTOMER DID NOT INSTRUCT HIM TO LEAVE THE CASH IN MONEY MARKET FOR A REAL ESTATE INVESTMENT. THE FA AND CUSTOMER MET IN PERSON TO REVIEW CUSTOMER'S ASSETS IN ALL OF HIS INVESTMENT ACCOUNTS AFTER 1/08, AND CUSTOMER DID NOT INFORM THE FA OF HIS CONCERNS. BASED ON THE FOREGOING, THE COMPLAINT IS DENIED.
