## **IAPD Information About Representatives**

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

### **What is included in a IAPD report?**

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

### **Where did this information come from?**

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

| <b>Broker Statement</b>     | I SUBMITTED MY LETTER OF RESIGNATION TO JOHN HANCOCK DISTRIBUTORS, INC. ON JUNE 1, 1994. MY U-5 REFLECTS A FORMAL TERMINATION ON 6/7/94. THE RESIGNATION WAS ENTIRELY VOLUNTARY AND HAD NOTHING TO DO WITH ANY PENDING INVESTIGATION BY JOHN HANCOCK OR THE NASD. I RESIGNED BECASUE I HAD ACCEPTED A NEW POSITION WITH THE GUARDIAN LIFE INSURANCE CO. AND GUARDIAN INVESTOR SERVICES. IT WAS NOT UNTIL SEVERAL WEEKS AFTER I RESIGNED THAT I ACTUALLY LEARNED OF A JOHN HANCOCK INTERNAL INVESTIGATION INTO "UNAUTHORIZED USE OF ADVERTISING AND SALES LITERATURE." THE FIRST NOTIFICATION OF THIS INVESTIGATION THAT I RECEIVED WAS DATED 6/20/94. I RECEIVED THE ACTUAL LETTER SEVERAL DAYS LATER. THE U-5 FILED BY HANCOCK DATED 6/20/94 CLEARLY INDICATED THAT THE TERMINATION WAS VOLUNTARY. THE DRP-5, HOWEVER, INDICATED THERE WAS AN INTERNAL REVIEW WHICH STARTED ON 2/8/94, I WAS COMPLETELY UNAWARE OF THIS. I WAS NEVER INFORMED OF SUCH A REVIEW UNTIL THE MATTER WAS COMPLETELY CLOSED ON 6/7/94. ALTHOUGH MY RESIGNATION TECHNICALLY OCCURRED DURING THE INTERNAL INVESTIGATION, I MUST EMPHASIZE THAT IT HAD ABSOLUTELY NOTHING TO DO WITH IT AND IN NO WAY WAS I FORCED TO RESIGN, PERMITTED TO RESIGN OR ENCOURAGED TO |



RESIGN. I RESIGNED SIMPLY TO PURSUE A BETTER OPPORTUNITY ELSEWHERE.
