What is included in a IAPD report?

Where did this information come from?

Allegations: Without admitting or denying the findings, Childers consented to the sanctions and to the entry of findings that, in connection with a customer's purchase of a variable annuity, he failed to timely execute the customer's transaction, which resulted in an almost four-month delay in the customer's investment. The findings stated that in order to belatedly execute this transaction, Childers re-dated the customer's variable annuity application, thus falsifying the document. Childers' falsification of the date on the customer's variable annuity application caused his member firm to maintain inaccurate books and records. The findings also stated that to create the false impression that he had already submitted the variable annuity transaction for approval, Childers provided the customer with a falsified variable annuity account statement. When the firm discovered Childers' falsification of the customer's variable annuity application and creation of a false variable annuity statement, Childers admitted to his misconduct and was permitted to resign from the firm.
