IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

RETIRED CLIENT AUTHORIZED TRANSFER OF FUNDS FROM A MUTUAL FUND MONEY MARKET INTO A FIXED ANNUITY. IN ORDER TO EXPEDITE THE TRANSFER OF FUNDS, I SIGNED THE NAME OF A FICTICIOUS PERSON ON THE TRANSFER FORM, RESERVED FOR THE PLAN ADMINISTRATOR, TO ACKNOWLEDGE CLIENT IS RETIRED.

MY DECISION TO SIGN THE FORM WAS BASED ON MY DESIRE TO ASSIST THE CLIENT WITH THE EXPEDITIOUS HANDLING OF THE TRANSFER. IN ADDITION, SEVERAL CURRENT EMPLOYEES OF THE RETIRED EMPLOYEES' COMPANY, HAVE STATED OVER THE LAST FEW YEARS THAT THE PLAN ADMINISTRATOR WAS QUITE SLOW IN PROCESSING REQUESTS. I WAS CONCERNED THE CLIENT WOULD BE NEGATIVELY AFFECTED BY A RATE DECREASE IF THE TRANSFER PROCESS WAS DELAYED.

FINRA INVESTIGATION CLOSED THE CASE DECEMBER, 2011 AND DETERMINED THAT MY ACTIONS DID NOT MERIT DISCIPLINARY ACTION, SANCTIONS OR FINES.
