What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Allegations: This is a product case, in which the firm was the only named respondent. The claim alleges that the firm did not conduct a reasonable due diligence of the product purchased by the client, Hospitality Investors Trust, Inc. ("HIT"), a publicly registered non-traded real estate investment trust. HIT was issued by American Realty Capital Properties, Inc. The client purchased \$50,000 of HIT on or about 10/22/2015. HIT subsequently filed for Chapter 11 bankruptcy in May, 2021, and is ongoing.
