IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

CLIENT STATES HE LOST VALUE IN ANNUITIES, MUTUAL FUNDS, FIXED INCOME INVESTMENTS, ETC. CLIENT ALLEGES THAT AS A RESULT OF IR'S ADVICE, CLIENT HAS LOST APPROXIMATELY \$25,000.

Broker Statement ACCORDING TO IR, HE RECEIVED CLIENT'S CORRESPONDENCE AS A RESULT OF AN ANNUAL REVIEW LETTER THE CLIENT RECEIVED FROM IR'S



OFFICE. IR INDICATED HE CONTACTED THE CLIENT AFTER RECEIVING CLIENT'S CORRESPONDENCE AND WAS INFORMED THE CLIENT HAD INCURRED LOSSES AS A RESULT OF INVESTMENTS IN AMERICAN FUNDS, LINCOLN NATIONAL (AMERICAN LEGACY) AND PUTNAM FUNDS. IR FURTHER INDICATED HE EXPLAINED THE DECLINE IN THE VALUE OF THE AFOREMENTIONED INVESTMENTS WAS DUE, IN PART, TO THE WITHDRAWALS BEING MADE FROM THE INVESTMENTS. IR STATED HE HAS REPEATEDLY CAUTIONED CLIENT REGARDING THE WITHDRAWALS AND ADVISED THE CLIENT IR DID NOT BELIEVE THE GROWTH OF THE ACCOUNT WOULD KEEP PACE WITH THE WITHDRAWALS. ACCORDING TO IR'S CALCULATIONS, IT DOES NOT APPEAR CLIENT ACTUALLY INCURRED ANY LOSSES WITH THESE INVESTMENTS. IT IS UNDERSTOOD THE CLIENT INVESTED APPROXIMATELY \$98,046, WITHDRAWN APPROXIMATELY \$93,174 AND THE APPROXIMATE VALUE OF THE INVESTMENTS AS OF JULY 20, 2004 WAS \$74,280. IT WOULD APPEAR THE DECLINE IN CLIENT'S ACCOUNT IS DUE, IN PART, TO WITHDRAWALS. HOWEVER, THE INVESTMENTS ARE ALSO SUBJECT TO MARKET FLUCTUATION, WHICH COULD HAVE CONTRIBUTED TO SOME OF THE DECLINE IN THE VALUE. BASED ON OUR REVIEW, WE WILL BE MAKING NO ADJUSTMENTS TO THE ACCOUNT IN REGARD TO THIS SITUATION.
