What is included in a IAPD report?

Where did this information come from?

Allegations: 6/6/07-9/00/08; CLIENTS CLAIM THEY WANTED TO START PURCHASING CDS AS THEY NO LONGER WANTED RISK AS HE WAS LOOKING AT RETIRING IN 3 TO 4 YEARS. CLIENT CLAIMS THE FA CONTINUED TO PRESSURE THEM INTO THE MUTUAL FUNDS AND, AFTER SEVERAL WEEKS, FINALLY PURCHASED THEM. CLIENT CLAIMS THE FA INFORMED HIM THE AMERICAN FUNDS CONTINUOUSLY PRODUCED 8% AND CLIENT STATED HE INFORMED THE FA THAT HE EXPECTED THE FUNDS TO GROW 6% EVERY 12 MONTH PERIOD (NOT THE 8% THE CLIENT CLAIMS THE FA ALL BUT GUARANTEED) AND, IF THE FUNDS COULD NOT DO THAT, HE WANTED TO GO WITH THE CDS. THE CLIENT CLAIMS THE FA WAS ADAMANT AND CONFIDENT THE FUND WOULD MEET THESE EXPECTATIONS. CLIENT IS REQUESTING HIS FULL \$80,000 BACK (NOT AS CONCERNED WITH WIFE'S ACCOUNT AS THERE IS STILL APPROX. 17 YEARS BEFORE SHE USES THESE FUNDS). CLAIM EXCEEDS \$5,000
