What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

OUR REVIEW FOUND THE ADVISOR'S RECOMMENDATION WAS SUITABLE BASED ON THE CLIENTS' STATED GOALS AND OBJECTIVES. THEY HAD A MINIMUM TEN-YEAR TIME HORIZON, AND AS SUCH DID NOT REQUIRE ACCESS TO THE FUNDS DURING THE NEW SURRENDER CHARGE PERIOD. THOUGH THE EXISTING CONTRACT FIXED ACCOUNT PAID A HIGHER INTEREST RATE, THE ADVISOR'S RECOMMENDATION WAS BASED ON HIS UNDERSTANDING THAT THE FUNDS WOULD BE REALLOCATED TO EQUITY-BASED SUB-ACCOUNTS FOR GREATER GROWTH POTENTIAL THE NEW CONTRACTS OFFERED GREATER SUB-ACCOUNT SELECTIONS, LOWER ADMINISTRATIVE FEES, AND INCREASED DEATH BENEFIT, AND A 1% PURCHASE CREDIT. FINALLY, THE CLIENTS SIGNED REPLACEMENT DISCLOSURE FORMS.
