IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Broker Statement

I DENY THE ALLEGATIONS MADE IN THIS MATTER. THE RECOMMENDATION TO PURCHASE A REIT IN 2005 WAS INTENDED TO PROVIDE THIS LONGTIME CUSTOMER (13 YEARS AT THAT TIME) WITH ADDITIONAL DIVERSIFICATION TO REAL ESTATE, WHICH WAS A COMMON PRACTICE AT THE TIME. THE INVESTMENT WAS FULLY DISCUSSED, DOCUMENTED AND AUTHORIZED AT THAT TIME. AS A RESULT OF SUCH HISTORIC AND UNPRECEDENTED EVENTS AS THE GLOBAL CREDIT CRISIS AND THE SUBPRIME MORTGAGE SCANDAL, MANY ECONOMIC SECTORS, INCLUDING REAL ESTATE, WERE NEGATIVELY AFFECTED. THIS RESULTED IN A REDUCTION IN THE VALUE OF THE REIT AND RESTRICTIONS ON ITS LIQUIDITY. I BELIEVE THAT THE ALLEGATIONS IN THIS MATTER WERE MADE WITH THE BENEFIT OF HINDSIGHT, AND THAT MY RECOMMENDATION WAS SUITABLE AND APPROPRIATE AT THE TIME IT WAS MADE. I WAS NOT CONSULTED BY MY FORMER FIRM ABOUT THE DECISION TO SETTLE THIS MATTER, AND WAS NOT ASKED TO MAKE A FINANCIAL CONTRIBUTION TO THE SETTLEMENT.
