What is included in a IAPD report?

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Broker Statement The statement regarding fees of trade not being disclosed is not accurate; as all fees for trades were discussed with clients as documented in RJ client notes. All trades were done under the Raymond James trading guidelines for UIT trades which allowed for early termination based on performance thresholds. In addition, all trades were principal approved by Raymond James.
