IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Broker Statement

I recommended purchases in two ETFs (JEPI and JEPQ) based on my research of these investments and my analysis that they were appropriate and suitable for the clients to whom the transactions were recommended. Each trade was discussed in advance with the involved client and approved prior to execution. Each trade was posted onto Truist's trading platform and available for Compliance review. I was not counseled that the trades violated any policy or even given an opportunity to adapt the use of these ETFs to meet any concerns that Truist had, and for which were never explained to me. In summary, no letter or writing was issued by Truist informing me of their concern, explaining what their concern was, and giving me an opportunity to make any corrective action to address their concern. Until this unwarranted and unjustified discharge by Truist, my record in the securities



industry had been unblemished for my entire career spanning over 30 years.
