What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

 - A "resolved" matter usually includes a disposition wherein no payment is made to the customer or there is no finding of wrongdoing on the part of the Investment Adviser Representative. Such matters generally involve customer disputes.

Broker Statement	Had confrontation at an ice rink with my son's hockey coaches wife. She pushed and struck me. I through my hand in the air to defend myself. I was charged with disorderly conduct by Bethel Park Pa police. Plaintiff later went to DA office and I was charged with simple assault, disorderly conduct and harassment. I went to hearing and they charged me with aggravated assault because plaintiff wasn't going to work. My clients testified that she hit me first but I was convicted of



aggravated assault. Final decision was a year and a half of house arrest and three years probation. My appeal was denied. I served the sentence and all ended on 6/5/2022.
