IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Allegations:	12/05-4/09; ATTORNEY CLAIMS HIS CLIENT ESTABLISHED AN ACCOUNT WITH EDWARD JONES/THE FA. IN THE BEGINNING THINGS SEEMED TO GO WELL; HOWEVER, THE ATTORNEY ALLEGES (BY 2007) THE FA PROVIDED IMPROPER AND UNSUITABLE ADVICE TO THE CLIENT. THE ATTORNEY CLAIMS THE FA ESTABLISHED A MARGIN ACCOUNT THAT WAS ABUSED AND NOT APPROPRIATE. ATTORNEY STATES THE CLIENT DID MAKE WITHDRAWALS FROM THE ACCOUNT; HOWEVER, DUE TO THE MISMANAGEMENT OF THE MARGIN ACCOUNT, THE ACCOUNT HAD DECLINED SIGNIFICANTLY IN VALUE. ATTORNEY REQUESTS A SETTLEMENT FROM THE FIRM TO EQUAL ONE-HALF OF THE LOSSES INCURRED BY THE CLIENT (WHICH HE CALCULATES TO BE APPROXIMATELY \$56,828.25 AS WELL AS THE MARGIN INTEREST CHARGES INCURRED.

Broker Statement

BASED ON OUR REVIEW, THE FA APPEARS TO HAVE MADE HIS INVESTMENT SUGGESTIONS BASED ON HIS DISCUSSIONS WITH THE CLIENT. IN ADDITION, IT DOES NOT APPEAR THE INVESTMENTS PURCHASED AND/OR HELD IN THE ACCOUNT WERE OUTSIDE THE SCOPE OF THE CLIENT'S OBJECTIVES. THE PURCHASES WERE EVIDENCED THROUGH TRADE CONFIRMATIONS AND ACCOUNT STATEMENTS. AS WE HAVE RECEIVED NO RETURN MAIL FOR THE ACCOUNT, WE WOULD ASSUME THE CLIENT RECEIVED HIS STATEMENTS AND, AS SUCH, HE WAS AWARE OF THE LOAN BALANCE AS WELL AS THE ASSOCIATED INTEREST CHARGES. ALTHOUGH THE ATTORNEY HAS INDICATED THE CLIENT SUFFERS FROM "MENTAL LIMITATIONS", WE HAVE RECEIVED NO INFORMATION TO INDICATE THAT HE IS (OR WAS) INCAPACITATED. IN ADDITION, WE HAVE NO RECORD OF ANY INDIVIDUAL BEING AUTHORIZED TO ACT ON BEHALF OF THE CLIENT WITH REGARD TO HIS EDWARD JONES ACCOUNT. WE UNDERSTAND THE CLIENT'S FRUSTRATION WITH THE DECLINE IN THE VALUE OF THE ACCOUNT; HOWEVER, THE CLIENT TOOK SUBSTANTIAL WITHDRAWALS FROM THE ACCOUNT WHICH CONTRIBUTED TO THE DECLINE. UNFORTUNATELY, DURING THE SAME TIME FRAME, WE EXPERIENCED A PERIOD OF UNPRECEDENTED MARKET CONDITIONS WHICH HAD A SIGNIFICANT IMPACT ON VALUATIONS. BASED ON OUR REVIEW, IT IS OUR OPINION THE TRANSACTIONS EFFECTED IN THE CLIENT'S ACCOUNT WERE COMPLETED WITH HIS KNOWLEDGE AND AUTHORIZATION. THEREFORE, WE ARE DENYING THE ATTORNEY'S REQUEST FOR A REIMBURSEMENT OF ANY PORTION OF THE LOSSES ASSOCIATED WITH THE TRANSACTIONS EFFECTED IN THE ACCOUNT. HOWEVER, WE ARE EXTENDING AN OFFER TO CLIENT IN THE AMOUNT OF \$12,508.25 WHICH REPRESENTS THE MARGIN INTEREST CHARGES HE INCURRED. CLIENT HAS ACCEPTED OUR OFFER AND THE COMPLAINT HAS BEEN CLOSED.
