IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Allegations: CLIENTS TRANSFERRED INHERITED ACCOUNT TO THE BRANCH EXPLAINING THEY WANTED TO USE THE SIX MONTH LATER OPTION FOR ESTATE VALUATION BASED ON THE DATE OF DEATH OF THE OWNER. IN DECEMBER 2010, THE FINANCIAL ADVISOR RECOMMENDED SELLING EXISTING POSITIONS TO MOVE TOWARD A DIVERSIFIED MANAGED PORTFOLIO, AND THE CLIENT ALLEGES THE FINANCIAL ADVISOR ASSURED THE CLIENT THERE WOULD BE NO TAX CONSEQUENCES. UPON COMPLETION OF 2010 TAX FILING, THE CLIENTS ARE FACED WITH A \$100,000 TAX BILL, AND INDICATE THE ESTATE WAS NOT PROPERLY VALUATED, WHICH RESULTED IN POOR ADVICE. THE CLIENTS INDICATE HAD THEY BEEN PROPERLY INFORMED OF THE TAXABLE GAINS, THEY WOULD NEVER HAVE MADE THE TRANSACTIONS.
