What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

WE RECOMMEND WAYS TO CONVERT THE EXISTING PLAN TO COMPLIMENT THE BROKER'S RECOMMENDATIONS THUS SAVING THE CLIENT FROM POTENTIAL LOSSES BUT THE BROKER ADVISED AGAINST IT.

MET WITH CLIENT TO DISCUSS IRA ROLLOVER OPTION. I REVIEWED ASSET ALLOCATION OPTIONS WITH MUTUAL FUNDS AND THE LIVING BENEFITS WITH VARIABLE ANNUITIES. CLIENT WANTED THE LIVING BENEFITS OPTION AND CHOOSE THE VARIABLE ANNUITY. I DISCLOSED ALL OF THE FEES AND COMPLETED ALL NECESSARY DOCUMENTATION. AFTER ISSUANCE OF POLICY THE CLIENT CALLED AND STATED HE WAS NOT AWARE HE PURCHASED A VARIABLE ANNUITY AND WANTED TO "FREE LOOK" THE POLICY. I TRIED TO REITERATE WHY HE CHOOSE THE ANNUITY, BUT THE CLIENT WAS ADAMANT ABOUT REVERSING THE TRANSACTION. THE TRANSACTION WAS REVERSED AND THE CLIENT RECEIVED BACK HIS PRINCIPAL INVESTMENT (NO SURRENDER FEES ASSESSED). UNCLEAR WHY THE CLIENT FELT HE WAS ENTITLED TO MORE THAN HIS INITIAL INVESTMENT IF HE NEVER WANTED THE ANNUITY.
