THE CLIENT FURTHER ALLEGES THAT IT WAS HIS UNDERSTANDING THAT THE PREMIUM SCHEDULE SUGGESTED BY THE REPRESENTATIVE WOULD POTENTIALLY PROVIDE HIM GENEROUS CASH VALUES FOR FUTURE RETIREMENT NEEDS, IN ADDITION TO FUNDING A DEATH BENEFIT OF \$750,000.
