What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

Where did this information come from?

NYSE REGULATION ON THE SAME CLAIMS IN APRIL 2007 AND DID NOT NAME THE FINANCIAL ADVISOR AS A PARTY. MERRILL LYNCH SUBSEQUENTLY SETTLED THE ARBITRATION, FINRA CASE NO. 2007-016708, FOR A PAYMENT OF \$12,500 SOLELY TO AVOID THE EXPENSE AND DISTRACTION OF A HEARING. OWING TO THE AMOUNT OF THE SETTLEMENT RELATIVE TO THE SIZE OF THE CLAIM, THE FINANCIAL ADVISOR HAS OPTED TO DISCLOSE THE FINAL RESOLUTION. FINANCIAL ADVISOR DID NOT CONTRIBUTE TO THE SETTLEMENT. IN-HOUSE COUNSEL FOR MERRILL LYNCH DID NOT FIND EVIDENCE OF ANY SALES PRACTICE VIOLATION BY FINANCIAL ADVISOR.
