**Firm Statement** THE PURCHASE OF 4000 RJR NABISCO HOLDINGS 10% TOPRS TOTALING \$1181.32. THE RJR NABISCO 10% PREFERRED STOCK WAS PRESENTED AS A LONG TERM INVESTMENT. THE CUSTOMER, HOWEVER, BELIEVED THE INVESTMENT WOULD BE CALLED BACK PREMATURELY AT \$25.00 PER SHARE IN AUGUST 1998. THE PREFERRED STOCK WAS NOT CALLED BUT MAINTAINED ITS VALUE AND CONTINUE TO PAY DIVIDENDS AT



10%. OLDE CANCELLED THE TRADE AND DEBITED THE CUSTOMERS ACCOUNT FOR INTEREST. THE FIRM SUFFERED NO LOSS AS A RESULT OF CANCELLING THE TRADE OTHER THAN THE \$1,182.32 CREDIT ADJUSTMENT. OLDE PREVIOUSLY SUBMITTED A FORM U4 DISCLOSING THIS MATTER TO THE NASD/CRD. THE FIRM LISTED THE AMOUNT OF ALLEGED DAMAGES AS \$10,000.00, THE PURCHASE PRICE OF THE SECURITY BECAUSE THE FIRM HAD PREVIOUSLY BEEN ADVISED BY THE NASD THAT THE TOTAL PURCHASE/SALE PRICE VERSUS THE COST OF CANCELLING THE TRADE WAS THE AMOUNT USED FOR REPORTING PURPOSES.
