**Broker Statement**

On June 19, 2017 my Maryland Life and Health Insurance license was suspended because I was more than 120 days delinquent on making my full child support payments. At the time I was working as a server in Ocean City, MD which is a very seasonal resort city. Most of my earning were made July through mid September and I could not afford the \$1500 a month child support payments when I only made around \$25,000 for the year. I tried to have the child support payments lowered through Maryland Child Support Services and, after 9 months, I found out they denied my request. All of the back child support has been paid and I have made the necessary payments for 3 years now.
