IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

THE TRADE IN QUESTION INVOLVED AN OPEN-END MUTUAL FUND THAT WAS SUITABLE FOR THE CLIENT AND MET THE CLIENT'S OBJECTIVES. THE FUND WAS DISCUSSED AND AGREED TO PRIOR TO THE TRADE. HOWEVER, I LATER LEARNED THAT IT WAS NOT ON THE FIRM'S APPROVED LIST. I RESPECTFULLY DISAGREE WITH THE FIRM'S ASSERTION THAT I WAS NOT TRUTHFUL DURING THE COURSE OF AN INVESTIGATION, AND ITS SUGGESTION THAT I INTENTIONALLY MISMARKED THE TRADE INFORMATION. THE CUSTOMER WAS PLEASED WITH THE TRADE IN QUESTION AND DID NOT INITIATE A CUSTOMER COMPLAINT.
