The advisor worked closely with the client and his firm's research department to design a well-diversified mutual fund portfolio to meet her long-term investment objectives. The client was day trading internet stocks at another firm, but the rep would not allow that type of activity in the account he advised on. After the stock market crash of the early 2000's, the client had heard that Wall Street firms would likely settle many claims brought against client losses. She called the rep to apologize to him that she would be filing a complaint to see if she could get a settlement although she believed he did nothing wrong.
