**Allegations:** CLIENT STATES THAT WHEN HE WAS HAVING TAXES DONE FOR 2002 THERE WAS A \$24,000 INCREASE IN INCOME AND TAX ADVISOR STATED THAT THIS WAS FROM LIQUIDATIONS FROM CLIENT'S HARTFORD ANNUITY. CLIENT STATES THAT \$24,000 OF THE ANNUITY HAD BEEN SOLD TO BUY \$30,000 OF LORD ABBETT BALANCED SERIES CLASS A SHARES, AND THAT THERE HAD BEEN AN ELECTRONIC TRANSFER OF \$2,000 PER MONTH GOING TO HARTFORD BALANCED FUND. CLIENT STATES THAT HE DID NOT AUTHORIZE THESE TRANSACTIONS. CLIENT WANTS TO BE COMPENSATED FOR THE ADDITIONAL TAX BURDEN THAT CLIENT CLAIMS HE IS NOW LIABLE FOR. DOES NOT SPECIFY AMOUNT. LOSSES COULD POTENTIALLY EXCEED \$5,000.

A CONFIRM WAS RECEIVED AS WELL AS THE INVESTMENT BEING REFLECTED ON MONTHLY STATEMENTS. CLAIM DENIED.
