IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Broker Statement MERRILL LYNCH DENIED THE CUSTOMERS' ALLEGATIONS IN THEIR ENTIRETY. THE COMPLAINT WAS PROMPTED BY THE DECREASE IN VALUE OF MUNICIPAL FUNDS DUE TO RISING INTEREST RATES. PURSUANT TO THE CUSTOMERS' INSTRUCTION TO REDUCE RISK BY REDUCING THE AMOUNT INVESTED IN EQUITIES, MR. MCAULEY RECOMMENDED CERTAIN



EQUITY POSITIONS BE SOLD AND THE PURCHASE OF A MUNICIPAL FUND TO ACCOMPLISH THE OBJECTIVE OF REDUCING TAX LIABILITY. CASH WAS STILL ACCESSIBLE IN THEIR ACCOUNT AND THE EQUITIES SOLD WERE NOT PURCHASED AT MERRILL LYNCH. MR. MCAULEY REQUESTED THE DATES OF PURCHASE AND PROVIDED THE CUSTOMERS WITH A COSTS BASIS HISTORY TO GIVE TO THEIR TAX ADVISOR. MR. MCAULEY ALSO DENIED ALL ALEGATIONS AND ASSERTED THAT HE COMPLIED WITH CUSTOMERS' INSTRUCTIONS AND ALL REQUESTED OBJECTIVES WERE MET.
