**Broker Statement** TAXPAYER DID NOT PROVIDE ALL INFORMATION NECESSARY, WHEN ASKED ABOUT INFORMATION TAXPAYER STATED IT WAS COMPLETE. HOWEVER DOCUMENTATION MADE BY ME WAS NOT COMPLETE ENOUGH TO VERIFY CLIENT STATEMENT. AS A RESULT IRS SAID I DID NOT TAKE A REALISTIC POSITION ON THE TAX RETURN. I WAS UNABLE TO PROVE OTHERWISE BECAUSE OF LACK OF DOCUMENTATION OF CLIENT STATEMENTS. SINCE THEN, I HAVE INSTIGATED A BETTER DOCUMENTATION SYSTEM.
