What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Broker Statement I DENY ALL ALLEGATIONS. CLAIMANTS ARE KNOWLEDGEABLE AND EXPERIENCED INVESTORS WHO SOUGHT SPECIFIC INVESTMENTS IN ORDER TO DEFER SUBSTANTIAL TAX LIABILITIES FROM EXTENSIVE GAINS ON THE SALE OF BUSINESS REAL ESTATE HOLDINGS. CLAIMANTS SOUGHT THESE INVESTMENTS FOR TAX DEFERRAL AT THE RECOMMENDATION OF THEIR CPA DURING BUSINESS SALE TAX PLANNING. AFTER ONE OF THE SPECIALIZED REAL ESTATE PRODUCTS UTILIZED FOR CAPITAL GAIN TAX DEFERRAL COULD NOT RECOVER FROM THE UNPRECEDENTED REAL ESTATE MARKET DOWNTURN INCURRED IN 2008 THROUGH 2009, CLAIMANTS WERE SOLICITED BY THEIR ATTORNEY TO FILE THIS CLAIM. DURING DEPOSITION, WHEN CLAIMANTS WERE ASKED IF THE ALLEGATIONS FRAUD, LYING, AND WITHHOLDING INFORMATION APPLIED TO MYSELF, THEY CONSISTENTLY STATED "NO", TESTIFYING THAT MY PRIOR BROKER-DEALER AND THEIR DUE DILIGENCE TEAM WERE THE ONES AT FAULT. WITH NO CONTRIBUTION TO THE SETTLEMENT BY MYSELF, AS A BUSINESS DECISION, MY PRIOR BROKER-DEALER CHOSE TO SETTLE THIS MATTER.
