It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

### Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

MERRILL LYNCH AND MR. ROWE DENY THE CLIENT'S ALLEGATIONS IN THEIR ENTIRETY. CLIENT WAS CONCERNED WITH THE MARKET PERFORMANCE IN SEPTEMBER 2008 AND NEEDED TO REDUCE HER EXPOSURE TO THE STOCK MARKET. MR. ROWE LIQUIDATED ONE POSITION WHILE ANOTHER OF THE CLIENT'S HOLDINGS THAT WAS MADE UP ENTIRELY OF EQUITIES WAS DUE TO MATURE IN SEPTEMBER 2008. WHILE THE CLIENT DISCUSSED LIQUIDATING THE ENTIRE ACCOUNT, IT WAS MR. ROWE'S RECOMMENDATION TO ONLY LIQUIDATE A PORTION OF HER PORTFOLIO TO REDUCE HER MARKET EXPOSURE. THE CLIENT AGREED TO GO ALONG WITH THIS RECOMMENDATION. THE REMAINING POSITIONS CONSISTED OF BOND HOLDINGS THAT WERE PERFORMING WELL.
