### What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

### Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

MARGIN AGREEMENT IN HIS PRESENCE, OR AT THIS REQUEST. INSTEAD, THIS ACCOUNT WAS TRANSFERRED TO MR. HUFALT FROM AN ASSOCIATE MERRILL LYNCH OFFICE IN OHIO, AT THE REQUEST OF CUSTOMER. IT IS ALSO IMPORTANT TO NOTE THAT THE ORIGINAL ESTIMATE OF DAMAGES WAS INACURATE AND INFLATED AT \$5,000. ALTHOUGH MERRILL LYNCH AND MR. HUFALT FEEL THERE WAS NO WRONGDOING, MERRILL LYNCH MADE A BUSINESS DECISION TO SETTLE THIS MATTER, AND MERRILL LYNCH ACKNOWLEDGES THAT MR. HUFALT WAS NOT RESPONSIBLE FOR SETTING UP THE MARGIN STATUS ON THE ACCOUNT.
