**Broker Statement**

ON THE POSSESSION CHARGE, I RECEIVED A DEFERRED SENTENCING WAS DETERMINED THAT I DID NOT NEED TO GO TO A SUBSTANCE ABUSE PROGRAM I WAS GIVEN 4 YEARS PROBATION AND WAS RELEASED EARLY WITH AN HONORABLE DISCHARGE UPON RELEASE FROM PROBATION THE POSSESSION CHARGE WAS DROPPED. I LEARNED AN EXPENSIVE LESSON AND HAVE NOT BEEN IN ANY TROUBLE SINCE KR.
