What is included in a IAPD report?

In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and

Allegations: The clients sent a letter to FINRA on 7/8/2015. FINRA received the letter on 7/13/2015. FINRA created several information requests for Hantz Financial Services, Inc. on 8/12/2015 and included a copy of the clients' letter. Hantz Financial Services, Inc. responded to FINRA's request on 8/20/2015. The current status of this response is "Submitted." The clients alleged that the Variable Life Insurance Policy they applied for in September of 2014 was unsuitable and requested cancellation of the policy and redemption of the policy's cash value, without penalty.

Product Type: Insurance

Alleged Damages: \$7,354.30

Alleged Damages Amount Explanation (if amount not exact): On 07/31/2015 the cash value of the policy was \$13,120.44. The surrender cash value of the policy was \$5,766.14. Therefore the surrender charges associated with cancellation of this policy at the time of the complaint was \$7,354.30.
