What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

This section provides information regarding a customer dispute that was reported to the Investment Adviser Registration Depository (IARD) by the Investment Adviser Representative (IAR), an investment adviser and/or securities firm, and/or a securities regulator. Employing firm when activities occurred which led to the complaint: K.W. Chambers & Co.

Allegations: Claimants do not reference any dates or specific products in their Statement of Claim, other than referencing "alternative investments." Claimants also did not include the representative as a Respondent to this arbitration. The foregoing notwithstanding, Claimants purchased two investments commonly referred to as non-exchange traded REITs or alternative investments on or about February 8, 2015. Claimants allege that Respondent breached a fiduciary duty to Claimants, failed to conduct adequate due diligence, perform proper suitability analyses, provide balanced disclosures, implement appropriate internal controls, and to properly train its financial advisor. The Company's first notice of any complaint about this purchase from the Claimants was upon receipt of the notice of Statement of Claim filed by Claimants, nearly six and a half years after the purchase.
