**Broker Statement**

Client correspondence was regarding account fees following a transition from a prior firm related specifically to U.S. Treasury and cash-equivalent holdings within a single account, not to the entire account or to any other accounts. During the January-March 2026 billing period, those holdings were temporarily included in a fee-based advisory structure and billed at more than the intended lower-fee, resulting in a fee difference of \$4,732.80 limited to that portion of the assets. The matter was identified and corrected. The relationship remains ongoing and in good standing.
