What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

 - A "settled" matter generally represents a disposition wherein the parties involved in a dispute reach an agreement to resolve the matter. Please note that Investment Adviser Representatives and firms may choose to settle customer disputes or regulatory matters for business or other reasons.
 - A "resolved" matter usually includes a disposition wherein no payment is made to the customer or there is no finding of wrongdoing on the part of the Investment Adviser Representative. Such matters generally involve customer disputes.

Broker Statement THE FIRM FOUND THAT THE REPLACEMENT OF THE CLIENT'S TSA IN JUNE 2002 WAS SUITABLE FOR THE CLIENT GIVEN HER INVESTMENT



OBJECTIVES. THE FIRM ALSO FOUND THAT TERMS OF THE NEW ANNUITY, IN RESPECT TO SURRENDER CHARGES, HAD BEEN MISREPRESENTED TO THE CLIENT. THE FIRM OFFERED THE CLIENT THE ABILITY TO WITHDRAW \$1,000 MONTHLY FROM HER CURRENT TSA FREE OF SURRENDER CHARGE WHICH WAS CONSISTENT WITH THE CLIENT'S EXPECTATIONS AT THE TIME OF PURCHASE, AND ALSO THE REIMBURSEMENT OF SURRENDER CHARGES ALREADY INCURRED. THE CLIENT, HOWEVER, REFUSED THE FIRM'S OFFER AND THE MATTER WAS CLOSED. THE CLIENT HAS ACCEPTED THE FIRM'S OFFER AFTER ELECTING TO REVISIT THE ISSUE SIX MONTHS AFTER ITS INITIAL RESOLUTION.
