IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Allegations: THIS COMPLAINT WAS INITIATED AFTER THE CUSTOMER READ A NEWSPAPER ARTICLE ABOUT INAPPROPRIATE SALES OF VARIABLE ANNUITIES TO THE ELDERLY. PEOPLE'S SECURITIES RECEIVED THIS COMPLAINT FROM THE HARTFORD ON MAY 21, 2003 IN RESPONSE TO A REQUEST FROM THE CT DEPT. OF INSURANCE. IN HER COMPLAINT, SHE REQUESTED A REFUND ON THE \$150,929 VARIABLE ANNUITY PURCHASED IN JULY, 1999 BECAUSE THE CUSTOMER CLAIMED THAT THE INVESTMENT WAS UNSUITABLE, AND HAD SINCE LOST VALUE. IT HAS NOT BEEN DETERMINED THAT A VIOLATION OCCURRED, NOR DOES PEOPLE'S SECURITIES BELIEVE THAT THE COMPLAINT HAS MERIT. THIS COMPLAINT IS CLOSED AT THE HARTFORD, WHICH HAS NOT RECEIVED A FOLLOW-UP REQUEST FROM THE CT DEPT. OF INSURANCE. NEITHER THE HARTFORD NOR PEOPLE'S SECURITIES HAS MADE A MONETARY SETTLEMENT WITH THE CUSTOMER. TO OUR KNOWLEDGE, THE CUSTOMER HAS NOT PURSUED THIS MATTER ANY FURTHER. PEOPLE'S SECURITIES BELIEVES THAT A U4 DISCLOSURE IS INAPPROPRIATE IN THIS SITUATION, BUT HAS SUBMITTED ONE ON 9/18/2003.
