What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Allegations: PA RESIDENT WRITES THAT FA FAILED TO FOLLOW INSTRUCTIONS TO SELL 677 SHARES OF GE STOCK IN NOVEMBER 2003 AND REPURCHASE IT IN JANUARY 2004, INSTEAD SELLING THE SHARES ON DEC. 2, 2003 AND ONLY 500 SHARES REPURCHASED ON JAN. 5, 2004. ALSO WRITES THAT IN MARCH 2003, ON BROKER'S RECOMMENDATION, HE SOLD HIS LADDERED BONDS AND PURCHASED A SINGLE FHML BOND FOR \$48,838 WHICH WAS CONTRARY TO HIS LADDERING STRATEGY. ALSO WRITES THAT HE PURCHASED 2 GE ANNUITIES FOR \$50,000 EACH IN MAY 2003 BASED ON BROKER'S REPRESENTATIONS THAT ANNUITIES HAD MINIMUM ANNUAL RETURN OF 6%, BUT ACTUALLY WAS ONLY 3% GUARANTEED.
