CLIENT ASSUMED RESPONSIBILITY FOR LOSSES UNTIL APRIL 22, 1999. LOSSES AFTERWARD WERE \$51,418 AND CLIENT AGREED TO A \$40,000 SETTLEMENT. GROSS COMMISSIONS EARNED WERE REVERSED BY \$40,000 PLUS AN ADDITIONAL FINE OF \$2,500 AGAINST NET COMMISSIONS. ALSO, ALL OPTION TRADES MUST BE PRE-APPROVED FOR SUITABILITY BY A ROP FOR THE NEXT SIX MONTHS. CLIENT HAD BEEN SUCCESSFULLY TRADING OPTIONS THROUGH US SINCE JANUARY, 1999, AND INDICATED HE HAD SEVEN YEARS PRIOR EXPERIENCE TRADING OPTIONS. ON APRIL 15, 1999 CLIENT SOLD 200 UNCOVERED CALLS AND TRADE WAS MISTAKENLY PLACED IN TYPE 1 (CASH) INSTEAD OF TYPE 3 (SHORT). MISTAKE CONTINUED UNTIL CLEARING FIRM INFORMED US OF A \$1.8 MILLION MARGIN CALL. CLIENT WAS FORCED TO BUY BACK POSITIONS AT UNFAVORABLE PRICES TO COVER MARGIN CALL. CLIENT TOOK RESPONSIBILITY FOR ALL PROFITS AND LOSSES UNTIL APRIL 22, 1999. AFTERWARD, LOSSES AMOUNTED TO \$51,418 AND CLIENT SIGNED A RELEASE IN EXCHANGE FOR \$40,000.
