IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Objectives and Risk Parameters. Multiple investment options were offered with varying degrees of risk. Investor elected a Variable Annuity, with guaranteed income rider, stating that he did not need the funds near term. FA thoroughly reviewed the features and drawbacks of the Annuity and investor agreed to the stipulations of the contract. Investor authorized the investment and signed all the disclosure documents. Investor elected to make a subsequent investment into the existing contract. The client made unanticipated, large withdrawals from the annuity during a volatile market period which negatively impacted his contract value and income benefit. The claim was submitted 8 years after the initial purchase.
