IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Broker Statement

FORMER CLIENTS COMPLAIN THAT ROUND HILL SECURITIES, INC. AND MR. WILKINSON AS REGISTERED REPRESENTATIVE CONDUCTED UNSUITABLE TRADING IN CLIENTS ACCOUNTS. ROUND HILL SECURITIES, INC, AND MR. WILKINSON IN FACT HAVE RECEIVED WRITTEN COMMUNICATION SIGNED BY THESE CLIENTS DATED DECEMBER 29, 1998 IN WHICH THEY SPECIFICALLY AND CLEARLY DETAILED THE NATURE OF THEIR INVESTMENT OBJECTIVE AND THEIR INTENTIONS TO EMPLOY SPECIFIC TRADING TECHNIQUES. IN THIS SIGNED LETTER TO ROUND HILL, CLIENTS ALSO CONFIRMED THAT MR. WILKINSON HAS FULLY DISCLOSED THE RISKS INVOLVED WITH CLIENTS OBJECTIVES AND TRADING TECHNIQUES INCLUDING THE RISK OF LOSS OF PRINCIPAL. IN THE DECEMBER 1998 LETTER AS WELL AS A JANUARY 1999 PHONE INTERVIEW WITH A ROUND HILL COMPLIANCE OFFICER AND AN OCTOBER 1999 LETTER OF ACKNOWLEDGEMENT FROM ANOTHER ROUND HILL COMPLIANCE OFFICER WHICH CLIENT SIGNED AND RETURNED, THESE CLIENTS CONFIRMED IN EVERY INSTANCE THAT THE ACCOUNTS ACTIVITY WAS UNSOLICITED AND EXECUTED ACCORDING THEIR OWN DIRECTION. IN COMMUNICATIONS BOTH VERBALLY AND IN WRITING, THESE CLIENTS ASSURED BILL WILKINSON AND ROUND HILL'S COMPLIANCE OFFICERS THAT THEY WERE EXPERIENCED INVESTORS WHO UNDERSTOOD THE RISKS THEY WERE TAKING AND THAT THEY HAD SUFFICIENT RISK CAPITAL TO UNDERTAKE THE RISKS AND EXPENSES RELATED TO THEIR TRADING. IN A NOVEMBER 1999 REVIEW OF CLIENTS ACCOUNT ACTIVITY AND IN LIGHT OF THE POOR PERFORMANCE OF CLIENTS CHOSEN TRANSACTIONS, ROUND HILL INFORMED CLIENTS THAT THEY WOULD NO LONGER ACCEPT THEIR UNSOLICITED ORDERS EXCEPT FOR SELLING CURRENT HOLDINGS. ROUND HILL DECLINED THE CLIENTS REQUEST TO ALLOW THEM TO CONTINUE TRADING THEIR ACCOUNTS AT THE FIRM. CLIENTS SUBSEQUENTLY MOVED THE ACCOUNTS TO ANOTHER BROKERAGE FIRM AND HAVE WAITED ALMOST FOUR YEARS TO VOICE A COMPLAINT. THE COMPLAINT IS SHOWING A DENIED STATUS.
