What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Broker Statement

IN EARLY 2011, MATTHEW RENAUD CONVERTED RENAUD & CO FROM A SOLE PROPRIETORSHIP (BY WHICH THE FIRM HAD OPERATED SINCE ITS INCEPTION) TO A LIMITED LIABILITY CORPORATION (LLC). THE FIRM HOWEVER UNKNOWINGLY FAILED TO UPDATE ITS MISSOURI INVESTMENT ADVISER REGISTRATION UNTIL EARLY 2012. CONSEQUENTLY, FROM EARLY 2011 THROUGH EARLY 2012, THE FIRM WAS INCORRECTLY REGISTERED AS A SOLE PROPRIETORSHIP, WHEN THE FIRM SHOULD HAVE BEEN REGISTERED AS AN LLC. IN ADDITION, MR. RENAUD SHOULD HAVE ALSO BECOME REGISTERED SEPARATELY AS AN INVESTMENT ADVISER REPRESENTATIVE OF THE LLC WHEN THE FIRM CONVERTED TO AN LLC. AFTER LEARNING OF THE REGISTRATION OVERSIGHT, THE FIRM UPDATED ITS REGISTRATION AND THAT OF MR. RENAUD. AFTER CONDUCTING ITS AUDIT OF RENAUD & COMPANY, THE MISSOURI SECURITIES DIVISION IN AUGUST OF 2012 CENSURED MR. RENAUD AND THE FIRM FOR THE REGISTRATION OVERSIGHT, REQUIRED THE FIRM TO REIMBURSE THE DIVISION FOR AUDIT COSTS, AND REQUIRED THE FIRM TO REIMBURSE A CLIENT FOR A FIXED ANNUITY SURRENDER PENALTY AND OTHER ASSOCIATED COSTS INCURRED BY THAT CLIENT DURING THE PERIOD THE FIRM WAS INCORRECTLY REGISTERED. AN ADDITIONAL PAYMENT TO THE MISSOURI SECRETARY OF STATE'S INVESTOR EDUCATION AND PROTECTION FUND WAS ORDERED BUT HAS BEEN SUSPENDED PROVIDED THE FIRM DOES NOT VIOLATE THE MISSOURI SECURITIES ACT FOR A PERIOD OF THREE YEARS.
