What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

MR. PFEIFER'S INSTRUCTIONS WERE TO PURCHASE TRIPLE Q AND LIQUIDATE THE MUTUAL FUNDS. THE LIQUIDATIONS DIDN'T TAKE PLACE UNTIL APPROXIMATELY TWO WEEKS LATER WHICH CAUSED DEBITS IN THE ACCOUNTS. THE BRANCH MANAGER THEN CONTACTED ALL OF THE CLIENTS WITH DEBITS IN THEIR ACCOUNTS. THE CLIENTS INDICATED THAT THEY HAD BEEN IN CONTACT WITH MR. PFEIFER AND THAT HIS HANDLING OF THE ACCOUNT MET WITH THEIR APPROVAL.

THE BRANCH MANAGER INDICATED TO MR. PFEIFER THAT THE LACK OF TIMELINESS IN THESE TRADES WAS AGAINST COMPANY PROCEDURE. MR. PFEIFER WAS THEN "PERMITTED TO RESIGN".
