In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Allegations: ON 10/13/2000, THE NET ASSET VALUES OF HEARTLAND GROUP INC.'S SHORT DURATION HIGH YIELD MUNICIPAL FUND AND ITS HIGH YIELD MUNICIPAL BOND FUND (INDIVIDUALLY THE "FUND" AND COLLECTIVELY THE "FUNDS"), EACH AN OPEN-ENDED MUTUAL FUND, WERE REDUCED BY APPROXIMATELY 44% AND 70%, RESPECTIVELY, DUE TO ADJUSTMENTS IN PORTFOLIO SECURITY VALUATIONS. THE STATEMENT OF CLAIM NAMED AS RESPONDENTS, AMONG OTHERS, THE FUNDS, THEIR PORTFOLIO MANAGERS, HAI AS THEIR ADVISOR AND DISTRIBUTOR AND MR. KOHL, A CUSTOMER SERVICE REPRESENTATIVE EMPLOYED BY HAI.
